### **General Terms and Conditions (GTC)**

These General Terms and Conditions (hereinafter referred to as "GTC") set forth the terms and conditions regarding the use of the service available on the patikreka.hu website (hereinafter referred to as "Website") by the User.

By using the Website, the User acknowledges and accepts the terms and conditions included in this GTC document.

### Activities that can be associated with the Website:

The Website enables requesting English-Hungarian, Hungarian-English translation and proofreading services (via email, phone or by using the contact form).

The General Terms and Conditions specify the procedure for purchasing the service and also the conditions and details for using the services provided by the Website.

The Service Provider/Operator has the right to amend these General Terms and Conditions. The amended provisions shall become effective upon the next service order after their entry into force for the User.

If the User does not agree with the General Terms and Conditions, they can suspend ordering or using the service at any time.

#### Procedure for orders through the website

The User can order translation or proofreading services, request a quote or a service using the contact details provided on the website. Thereafter, arrangements regarding a potential order can happen via phone or email, and the order shall always be finalised by email: the exact task and the deadline, the fee for the service, the time and method of payment, and any other information relevant to perform the work are defined and confirmed in writing by the Service Provider/Operator and the User.

Method of payment: by bank transfer (dr. Réka Patik sole proprietor, account No. 16200254-10093270, Magnet Bank) or via PayPal in HUF or EUR (to the PayPal account of patikreka@yahoo.com).

The fee for the service shall not change between order and delivery.

The service fee does not include value added tax, as the Service Provider/Operator's company is VAT exempt. Consequently, it is not possible to include VAT in the invoice issued.

The placing of an order is considered a contract concluded electronically between remote parties, so the provisions of Act CVIII of 2001of Hungary on certain aspects of electronic commerce and specific services related to information society shall apply. The contract shall be governed by Decision 45/2014 (II.26.) of the Government of the Republic of Hungary on the detailed regulations of contracts between consumers and enterprises, and shall take into account the provisions of Directive 2011/83/EU of the European Parliament and the Council on consumer rights.

The General Terms and Conditions do not constitute a written document, and are not filed by the Service Provider/Operator, nor are they accessible afterwards.

The language of the contract is Hungarian.

# Withdrawal from the purchase

In case of a contract regarding the provision of a service, and after the service has been fully completed, the User shall not have the right to withdraw from the contract if the Service Provider/Operator commenced delivery with the express and prior consent of the User, and the User has acknowledged that after complete delivery of the service, they shall have no right whatsoever to withdraw from the purchase. The parties concerned will then have to agree on an alternative dispute resolution forum, which will ultimately decide on the case between them. The platform will then inform the parties about the fora that can act in the case. As soon as such agreement is reached about the forum, the online platform will forward the complaint.

If the parties fail to reach an agreement within 30 days, or the platform is also unable to identify any alternative dispute resolution forum that can be in charge of the dispute based on the details submitted, no further processing of the complaint will take place.
